Puppy Purchase Health Guarantee:

- 1) Our health guarantee is for the purpose of illness/genetic related items only. We do not offer any implied guarantee unless otherwise written herein. This contract is legally binding and is signed in and governed by the laws of the State of Ohio. The parties agree that all actions arising in connection with this agreement will be litigated exclusively by the court system of Butler County, OH. This contract is non-transferrable. **All Sales are Final except as noted.**
- 2) Buyer will receive a shot card with each puppy that shows current vaccinations and worming medications that have been given. Also included will be a copy of the most recent vet check. It is the buyers responsibility to keep this record and continue a vaccination and worming schedule per your vets recommendations, this will also include starting any elective treatments for fleas and heart worm . We will not be liable for any adverse reactions/illnesses due to buyer's vet choosing to disregard the shots done and re-vaccinate your puppy. Re-vaccinating a puppy can result in suppression of the immune system and subsequent illnesses.
- 3) Buyer must have the puppy examined for general health and a fecal test run by a licensed veterinarian within 5 days from date of purchase (excluding Sundays and holidays). **If buyer does not have the puppy examined, this contract is void.** At your first vet check should the puppy be diagnosed to have a life-threatening illness you are to contact **Mark Johnson immediately** to make arrangements to return the puppy or have the pup taken to a vet of the seller's choice. A refund or replacement puppy will be given in accordance with article #6. Seller is not liable for Hypoglycemia, (low blood sugar).
- 4) If the puppy were to be tested and diagnosed positive for Parvo or Distemper within 10 days from the date of purchase you must be contact **Mark Johnson immediately**. The puppy may be returned to the seller or a vet of the sellers' choice within 8 hours for you to receive a full refund. If you choose to have the puppy treated by your vet the maximum reimbursement will not exceed the purchase price of the puppy. See article #6 for refund and reimbursement requirements.
- 5) If the puppy is diagnosed to have a congenital or hereditary defect which would greatly reduce quality or quantity of life the following apply; within one year from their date of birth 100% of your purchase price will be refunded, within two years from their date of birth 50% of your purchase price will be refunded. If the puppy perishes or needs to be euthanized before its second birthday due to a suspected genetic disorder a gross necropsy must be performed by a vet of your choice. If the results of the necropsy reveal a conclusive genetic disorder as the cause of death then you will receive a full refund in accordance with article 6# plus up to \$150 to cover the cost of the necropsy.
- 6) **FOR CONSIDERATION OF ANY RETURN, REFUND OR REIMBURSEMENT:** Copies of all medical documentation from the date of purchase must either accompany the puppy or be sent to the seller before any refund will be granted. This info should include all signed and dated veterinary reports including diagnosis, test results and treatment. We reserve the right to have said documents reviewed or to have the puppy re-examined by one of our vets before any refund will be granted. If a difference of opinion should arise then a third opinion will be sought and majority opinion will be considered conclusive. No refund or reimbursement will exceed the original purchase price of the puppy.
- 7) Buyer assumes all responsibilities and costs associated with the purchase, care and continuation of shots, worming's and electives of the puppy. Seller will not be liable for accidents, personal injury, property damage, puppies that are neglected, or have not been seen by a veterinarian.
- 8) Please note that we sell all puppies for pets and companionship ONLY. We do not guarantee their breeding potential or breeding quality. We strongly recommend, for the health of the pup, that all puppies be spayed/neutered by 6 months of age.
- 9) Seller, at their sole discretion, may reimburse for testing and necessary medications if something minor like kennel cough, ear infections, ear mites, giardia or coccidiosis were to be found at the first vet check. Minor shall be defined as a total sum of less than \$100.00. Please contact Mark Johnson directly either by email or one of the phone numbers listed above.
